Schonowee & Lincoln Heights Residents - Fire Alarms

If you hear a fire alarm in one of your neighbor's apartments - Call 911 right away. Remember, the alarms at Schonowee and Lincoln Heights are not linked directly to the fire department. The Smoke Alarms are to warn you, and your neighbors, and it is up to each resident, or your neighbors to call 911.

Leaving Doors Ajar @ Schonowee Village

Residents at Schonowee Village have been propping entrance doors, or leaving them ajar. By doing this, you are risking the safety of yourself, and your neighbors. Some of the doors have been damaged in the process. Anyone caught leaving the doors open, will be referred to our Security Department for investigation and lease termination - and you will be charged for repairs to the doors! The cost for repair of the door or the doorframes can be in the hundreds of dollars.

Regular Garbage Disposal Rules

- Use the Compactor Chutes on a Daily Basis: Use small bags like Price Chopper plastic bags. <u>DO NOT USE LARGE BAGS</u>.
- Before placing in compactor chute, raw garbage must be in properly sealed bags.
- If you have garbage that is too big for chute CALL the HOTLINE.
- <u>DO NOT</u> place garbage anywhere else than the garbage chutes.
 Disposing of trash in the Ten Eyck Basement, or in trash cans in front of Ten Eyck, near the Lincoln Heights Community Room, or on Hamilton Street sidewalks at Schonowee Village is prohibited.
- Anyone caught violating these rules is in violation of your lease and SMHA may pursue eviction against anyone we know to be violating the trash rules.
- Dumping trash on any sidewalks is against SMHA rules and City of Schenectady Code, and the City has agreed to work with SMHA to fine violators for littering.

Rent is due on the 1st of each month for the current month. You must save during the current month to have the next month's rent money on the 1st of the month. Once you fall behind it is difficult to catch up. You and your family need a place to live. You must make your rent payment a <u>PRIORITY</u> item in your budget.

There is a new city ordinance for dog owners that you need to be aware of. Chapter 144 of the code of the city which regulates the ownership of dogs and other animals in the City of Schenectady has been amended. Here something's you need to know. Section 144-7, Unlawful behavior. It is unlawful in the city of Schenectady for an owner or person in possession of a dog:

- 1. To allow the dog to run at large on the streets and sidewalks of the city without being:
 - a. Properly restrained by an adequate collar and leash not to exceed 8 feet in length and
 - b. Accompanied by a responsible person over the age of 12.
- 2. To keep, harbor or maintain a dog that creates a nuisance by:
 - a. Loud barking.
 - b. Chasing vehicles, bicycles or pedestrians.
 - c. Defecating, digging or urinating on or otherwise causing damage to or destruction of property.

If an individual is convicted of 2 offenses within 1 year, stemming from different dates, of violating section 144-7 of this code, all their dog licenses will be deemed void. In order to be issued another dog license the additional condition of providing a liability insurance policy, with minimum coverage of at least \$50,000.

Section 144-7.1. Dangerous Dogs. Upon finding that a dog is a dangerous dog, the owner must obtain general liability insurance in the amount of \$100,000 for any injury which the dog may cause.

The above are just a few items in the city ordinance. If you would like a copy of the full ordinance on dogs, you may get a copy from your Project Manager or Occupancy Specialist.

Also a reminder to all residents who have a pet, you must register your pet with the housing authority and pay a \$100 security deposit. All dogs who are 4 months and older must have a dog license and these licenses must be renewed every year you own your dog!

AIR CONDIVIONERS

If you must have an A/C on during the winter months due to a health condition, you must provide a doctor's note. Otherwise, please remove them from your windows. If you do not remove your A/C from your window, we will assume you are using it and you will be charged. There will still be a \$20.00 charge per A/C per month your A/C is in your window. This charge is for ALL residents!

The Animal Protective Foundation (APF) located at 53 Maple Avenue, Scotia, New York 12302 is currently, offering low income clients who are Schenectady County residents and are in a New York State benefits program, discounts for spay and neuter fees. Full price for this procedure is normally \$80.00 the



discounted price is \$40.00. The contact phone number for the foundation is: **518-374-3944**We require our residents to follow the Schenectady Municipal Housing Authority Pet Policy. Our Policy requires that all pets are registered with SMHA. A pet deposit of \$100.00 is required at the time of registering a pet. Pets must be kept in the owner's apartment or on a leash at all times when outside the unit. No outdoor cages may be constructed. Pets will be allowed only in designated areas on the grounds of the property if SMHA designates a pet area for the particular site. **Pet owners must clean up after their pets and are responsible for disposing of pet waste. KEEP YOUR COMMUNITY COOKING SAFELY
