SMHA Pet Policy

To all SMHA Residents:

This is a friendly reminder to pet owners and future pet owners. The following is part of SMHA's Pet Policy which is found in the Admission and Continued Occupancy Policy book. This book is located in the lobby at 375 Broadway and in all Project Managers offices for your viewing.

- 1. Only ONE pet per apartment is allowed at any time unless permission is granted for additional pets by the Housing Authority. This request must be in writing. Any pet must be licensed according to local regulations in the name of the tenant.**
- 2. Dogs weighing more than 20 lbs will not be permitted; turtles weighing more than 16 oz will not be permitted. Caged rodents weighing more than 2 lbs will not be permitted. Fish tanks in excess of 10 gallons will not be permitted.**
- 3. A \$100.00 security deposit shall be charged to owners of dogs and cats. This amount will be applied, if necessary, for services for clean up and extermination necessary because of the pet upon the tenants vacating of the premises. These monies must be paid in full prior to permitting said pet it unit.**

Please follow the Pet Policy. If it is not followed, you may be in violation of your lease agreement. For more information on pets, please call your Project Manager or the Occupancy Department.



SECURITY NEWS



FROM THE DESK OF THE SECURITY COORDINATOR:

- ⇒ Summer is just around the corner. With nice weather windows are open and residents come outside. Please keep music at a reasonable level. If not, Schenectady Police Department can make an arrest under the loud music ordinance.
- ⇒ Residents, please help keep the property clean by using garbage cans instead of the ground.
- ⇒ A reminder: if your car is not registered or has no plates, it will be towed at YOUR expense to H & K.
- ⇒ Several more residents are in the process of being arrested for under reporting their income or not claiming any income.



FROM THE DESK OF THE TENANT INVESTIGATOR:

- ⇒ SMHA is stepping up enforcement of unreported income. Not reporting income, or a change of income, within 10 days is a serious lease violation and will be treated as such. Further, no reporting income is considered a crime and by SMHA rules and regulations, you will be arrested.
- ⇒ Part of this crime is also having a **“Person Not On Lease”** living with you because obviously, if that person has income you are not reporting that income to us. This is also considered fraud. **So please, don’t forget to report all income, no matter what.**
